पेन कार्ड संशोधन में ध्यान रखने योग्य महत्वपूर्ण बिंदु

1. यह सुविधा पेन पहले से बने हुए पेन कार्ड में सुधार (नाम, जन्म दिनांक, पिताजी का नाम, घरेलू पता) आदि में बदलाव अथवा खोये हुए पेन कार्ड को रीप्रिंट करने एवं फिजिकल पेन कार्ड को दुबारा मंगवाने हेतु उपलब्ध करवाई जा रही है
2. मूल विवरण में मामूली सुधार के लिए (यानी नाम, पिता का नाम, जन्म तिथि)। आयकर नियम 1962 के नियम 114(4) के तहत निर्धारित पहचान दस्तावेज * का कोई भी प्रमाण, जिसमें सही विवरण दर्शाया गया हो, प्रदान किया जा सकता है।
